

In the reference of above cited subject

On the basis of the documents produced by the School Management along with Affidavit, and after considering the recommendations by the District Education Officer (Sr. Sec) Amritsar and Director Education Department (Sr. Sec.) , Punjab, Mohali the required No Objection certificate for Matriculation Examination has been issued on below mentioned conditions:-

1. In future on any complaint / Inspection if this fact reveals that at the time of taking No Objection Certificate you have made an application on the basis of wrong information and or you are not following the instructions issued by the Punjab Govt. from time to time and like this the conditions mentioned in the Affidavit shall not be complied, then in this situation at any time this No Objection Certificate shall be revoked.
2. It shall be compulsorily to teach Punjabi in your school upto the tenth class and the CBSE New Delhi shall also compulsorily arrange or conduct the Punjabi Examination besides this it is further added that in case of non- compliance the same, No Objection Certificate shall be revoked immediately.



3. School Management shall strictly comply the rules made by the Education Department Govt. of Punjab issued Under Notification of RTI Act 2009 and rules made for the Punjab State under RTI Act 2009
4. The school Management shall be liable or promise to pay the Salary as well as other allowances etc. to his Teaching and Non-Teaching Staff like other Govt. employees After taking the Affiliation from CBSE New Delhi. As per Govt. guidelines school shall deposit reserve fund for his Teaching and Non-Teaching Staff at the time of Extension / up gradation to the concerned District Education Officer. In case of non-compliance of the same, No Objection Certificate shall be revoked immediately.
5. You and your Management affirm that whenever any information demanded by your District Education Officer or by any Senior Officer from the Education Department then the required information shall be provided to him as well as to provide him required assistance.
6. The inspection of Children safety, Public Health Sanitation and other conditions of issuing No objection Certificate shall be checked from time to time by the Punjab Govt. Officers.
7. The guidelines issued by the Govt. of Punjab through letter No. 2/93/2009/3C3/1360154 dated 26.11.2018 shall be complied strictly.




